A Child Development Associate (CDA) can be obtained in three settings: center-based, family childcare, and home visitor, with 120 hours of child care training required in the eight CDA content areas, with a minimum of 10 hours in each content area. The online training modules below meet the 120 clock hours of professional development required by the Council for Professional Recognition and are specific to a Preschool Setting.

The CDA Training Modules 1-8 are available as a course group rate. The <u>course group rate is \$159.00 per</u> person for 48 online courses that equal 120 hours of training required to earn your CDA.

(NOTE: The course group rate does not include any CDA Council Registration Fees, materials or exam. The course group rate covers the 120 hours of formal early childhood education training, covering the growth and development of children ages 3 to 5 years, with no fewer than 10 training hours in each of the eight CDA® subject areas.)

Teaching License Renewal (120 Hours of Professional Development)

After earning a teaching certification, educators from many states must maintain their credential. The Professional Educator License remains valid for five years in some states. At the end of five years, educators must complete 120 hours of professional development to renew their license. This requirement applies to all licensed teachers, including those with a master's degree. Teachers can meet the professional development requirement in many ways. They can complete college coursework at an accredited institution or take workshops or online professional development courses. (NOTE: Professional Development hours may vary for each state. Check with your state's licensing requirements).

CDA Eligibility Requirements

Three main requirements to meet eligibility include the following;

- 1. A minimum of a high school diploma/GED or current enrollment in a high school career/technical program is required to apply for the CDA.
- 2. A total of 480 clock hours of experience working with children within three years of beginning your application is required.
- 3. 120 hours of training in eight subject areas is required, all available in the Child Care Training Consultants, LLC online CDA coursework provided.

The CDA Application

Once you are eligible to complete the CDA application and completed the required coursework, you then need to purchase the CDA Competency Standards Book from the Council for Professional Recognition. This CDA Competency Standards Book provides you with all the steps required to prepare for the application process, including:

- Preparation of the Professional Portfolio a collection of resources.
- Reflective Statements of Competence
- Professional Philosophy Statement
- Family Questionnaires to be distributed to the families of children in your care; the questionnaires highlight areas of strength as well as areas of growth.

The next step is to start the Council for Professional Recognition's application process, either online or on paper. To apply for your initial CDA Credential, contact the CDA Council.

As part of the application process, you will select a CDA Professional Development (PD) Specialist from the Council's online directory. This person will observe you working with young children as part of the process. After you complete the CDA Application Process, you will need to take your Childhood Development Associate credential test. Information is located on the CDA website.

About The Child Development Associate (CDA) Credential™

The Child Development Associate (CDA) Credential™ is the most widely recognized credential in early childhood education (ECE) and is a key process on the path of career advancement in ECE. The Child Development Associate (CDA) Credential™ is based on a core set of competency standards, which guide early care professionals as they work toward becoming qualified teachers of young children. The Council works to ensure that the nationally-transferable CDA is a credible and valid credential, recognized by the profession as a vital part of professional development. The Child Development Associate provides knowledge of how to put the CDA Competency Standards into practice and understanding of why those standards help children move with success from one developmental stage to another. The CDA credential provides knowledge on how to nurture the emotional, physical, intellectual, and social development of children.

How many hours of work experience are required to apply for the CDA Credential?

You are required to complete 480 hours of professional work experience with young children. Your work experience must be with children of the correct age according to the CDA setting you are applying for. Your experience may be as a paid staff or volunteer. As a reminder, the CDA settings and age ranges are:

- **PRESCHOOL:** A center-based preschool setting is a state-approved child development center where a Candidate can be observed working with a group of at least eight children, all of whom are ages 3 through 5 years old.
- INFANT-TODDLER: A center-based infant-toddler setting is a state-approved child development center
 where a Candidate can be observed working with a group of at least three children, all of whom
 are under the age of 3 years old.
- FAMILY CHILD CARE: A family childcare setting is a family childcare home where a Candidate can be
 observed working with at least two children 5 years old or younger who are not related to the Candidate
 by blood or marriage. The setting must meet at least the minimum level of applicable state and/or local
 regulations. Family childcare settings are also eligible in localities where there is no regulation of family
 childcare.

The Child Development Associate® National Credentialing Program and CDA® Competency Standards Book

Candidates applying for an initial CDA Credential are required to purchase a CDA Competency Standards book specific to the setting for which they are applying. The CDA Competency Standards book gives Candidates a detailed guide through the CDA credentialing process and requirements. This book and additional materials are available for purchase through the Council's website.

Introduction to the CDA Portfolio. The Competency Standards book provides information about the entire CDA Credentialing process and includes detailed instructions for completing your Professional Portfolio.

What is the Professional Portfolio?

The Professional Portfolio is intended to be a reflective professional development experience for you. You are encouraged to use and add to your Portfolio as you grow throughout your career. The Professional Portfolio is compiled independently by each Candidate as part of the CDA credentialing process. The compiled resources and documents are reviewed by the CDA Professional Development Specialist during the CDA Verification Visit. The Professional Portfolio is composed of:

- Education Documentation
- Family Questionnaires
- Six (6) Reflective Statements of Competence
- Ten (10) Resources
- A Professional Philosophy Statement

What are Family Questionnaires?

Family Questionnaires are a required component of the CDA Professional Portfolio. Candidates are required to distribute the questionnaires to the families they serve and include them in their CDA Professional Portfolio. The Family Questionnaires allow the Candidate to review and address feedback from the families they serve to aid in their professional development. The Family Questionnaires form you will use to distribute to families is included in your Competency Standards book. However, you can also find a copy of the form on the Council's website.

Continued Education Training

What forms of documentation of training can be submitted to the Council?

Proof of your professional education must include transcripts, certificates or letters (originals or copies) in your professional portfolio.

Reviewing Certificates or Transcripts

Acceptable Certificates

Official documentation of training must be provided in the form of a certificate, letter on official letterhead, or a college transcript. Training documentation should include:

- A. Training agency's name and address (seal/logo)
- B. Candidate's name
- **C.** Date of the training session(s)
- **D.** Content Areas
- E. Number of hours successfully completed
- F. Authorized signature
- **G.** Training Title/Topic

Unacceptable Certificates

- Training obtained from directors or training coordinators of programs that do not sponsor training
- Training obtained at conferences.
- Training obtained from individual consultants. (such as TA providers providing one-on-one training, etc)

Minimum of high school diploma/GED or enrolled in a high school career and technical program

CDA Candidates must have a high school diploma/GED or be currently enrolled in a family and consumer sciences education program in the area of Early Childhood Education/Child Development.

120 hours of education in 8 Subject Areas

Candidates must complete 120 hours of formal early childhood education training, covering the growth and development of children ages birth to 5 years, with no fewer than 10 training hours in each of the 8 CDA Subject Areas:

- 4. Building productive relationships with families

Professional Development (PD) Specialists

When filling out the CDA application, the CDA Candidate must include the ID number of the PD Specialist that has agreed to conduct the Verification Visit for the Candidate. To aid Candidates in locating a PD Specialist, the Council has provided a <u>FIND-a-PD Specialist</u> tool on their website or call the Council if you are unable to locate a PD Specialist. Be sure to review the PD Specialists Conflicts of Interest section of your Competency Standards book to ensure your selection is suitable.

Application

You may apply for your CDA either online or by mailing in a paper application. The fees for the two methods differ. If you choose to mail in your CDA application, you will find the application materials in your CDA Competency Standards book.

Scholarship

Check your place of employment for scholarships.

Ready to Schedule

Once your CDA application has been reviewed and approved by the Council, you will receive a *Ready to Schedule* notice informing you of the timeframe within which you must complete your Verification Visit and CDA Exam. It is important to include a valid email to ensure you receive this important information.

Verification Visit

After you receive your *Ready to Schedule* notice, you will contact your PD Specialist to set up a time for your Verification Visit. If you are in a center-based program, you must receive permission from your Director to schedule the Verification Visit, which will take about four hours. During your Verification Visit, you must be observed working as a lead teacher with a group of at least two children in a home-based program, and at least three children in a center-based program. The observation must take place at the center or home where the Candidate works or volunteers with children.

Professional Development (PD) Specialists

The CDA PD Specialist conducts the CDA Verification Visit with the Candidate. During the CDA Verification Visit the CDA PD Specialist:

- Reviews the Candidate's Professional Portfolio
- Observes the Candidate working with children
- Facilitates a reflective dialogue with the Candidate.

At the end of the CDA Verification Visit, the CDA PD Specialist electronically submits the Candidate's scores to the Council.

CDA Exam

After you receive your *Ready to Schedule* notice, you may schedule your CDA Exam found on the CDA website to find a testing center near you. The CDA Exam has 65 multiple-choice questions – 60 questions and 5 scenario questions (with a short narrative and photo). The Candidate will have up to one hour and 45 minutes to complete the exam.

How long will it take for the Council to make a credentialing decision?

There is no set timeframe for the Council to make a credentialing decision, as there are a number of factors that may delay the process. Generally, once a Candidate has successfully completed the CDA Exam and Verification Visit, the scores are transmitted to the Council within 24-48 hours. If there are no errors nor missing information, the credentialing decision may take 1-3 business days. If there is an error or information is missing, the review process to retrieve missing items and/or correct errors may take a minimum of 4-6 weeks for a credentialing decision to be made.

CDA Renewal

Will I be notified when it is time to renew my CDA Credential?

The Council will send a courtesy email reminder when it is time to renew your CDA credential. However, this email is a courtesy and is not guaranteed, nor should it be the sole reminder for renewing your CDA Credential. To help ensure you do not miss these courtesy reminders, please make sure the Council always has your current email on file.

When do I need to renew my CDA Credential?

Your CDA expires after 3 years. You may begin the renewal process well in advance of your application submission date and you may submit your renewal application up to 6 months before your expiration date.

Renewal Requirements

The Child Development Associate® National Credentialing Program Renewal Procedures Guide for Preschool, Infant-Toddler, and Family Child Care Settings provides detailed information about the steps you must take to renew your CDA. A brief overview of the Renewal steps are included below:

- Continued educational training
- First Aid and Infant and Child (Pediatric) CPR certification
- Minimum of 80 hours working with young children
- Choose an ECE Reviewer to complete your recommendation
- Membership in a national or local early childhood professional organization
- Visit the Council's website to view the CDA Renewal Procedures Guide

Module 1 - CDA Subject Area 1: Planning a Safe and Healthy Learning Environment consist of 7 classes and equals 13 clock hours/1.3 CEUs. It is the first of eight modules designed to meet the 120 classroom hours in the eight CDA Subject areas required to obtain a CDA. Module 1 also includes environmental health, potentially hazardous environmental factors, and safe appropriate procedures for ensuring age-appropriate toys for children of various age groups and developmental levels. The recommended childcare guidelines to emergency preparedness and response planning from natural disasters or man-made events and safe practices when transporting children are included in this section. Examples: Safety, first aid, health, nutrition, space planning, materials and equipment, play.

Course Description: The goal of this training is to inform participants on demonstrating good nutrition habits and wellness in the early childhood center. Identify the main causes of childhood obesity and the updated 2020 - 2025 Dietary Guidelines. Identify gross motor and coordination activities to share with families, benefits of exercising, developmentally appropriate environments for young children to incorporate into daily teaching practices!


ADDIE Model (Instructional Design)

Our training content is based on the ADDIE Instructional Model. The ADDIE model is the process traditionally used by instructional designers and training developers. The five phases—Analysis, Design, Development, Implementation, and Evaluation—represent a dynamic, flexible guideline for building effective training and performance support tools.

Phase 1: Analysis

In the analysis phase, instructional problem is clarified, the instructional goals and objectives are established, and the learning environment and learner's existing knowledge and skills are identified. Below are some of the questions that are addressed during the analysis phase:

- Who is the audience and their characteristics?
- Identify the new behavioral outcome?
- What types of learning constraints exist?
- What are the delivery options?
- What are the online pedagogical considerations?
- What is the timeline for project completion?



Phase 2: Design

The design phase deals with learning objectives, assessment instruments, exercises, content, subject matter analysis, lesson planning and media selection. The design phase should be systematic and specific. Systematic means a logical, orderly method of identifying, developing and evaluating a set of planned strategies targeted for attaining the project's goals. Specific means each element of the instructional design plan needs to be executed with attention to details.

These are steps used for the design phase:

- Documentation of the project's instructional, visual and technical design strategy
- Apply instructional strategies according to the intended behavioral outcomes by domain (cognitive, affective, psychomotor).
- Create storyboards
- The user interface and user experience
- Prototype creation
- Apply visual design (graphic design)

Phase 3: Development

The development phase is where the developers create and assemble the content assets that were created in the design phase. Programmers work to develop and/or integrate technologies. Testers perform debugging procedures. The project is reviewed and revised according to any feedback given.

Phase 4: Implementation

During the implementation phase, a procedure for training the facilitators and the learners is developed. The facilitators' training should cover the course curriculum, learning outcomes, method of delivery, and testing procedures. Preparation of the learners include training on new tools (software or hardware), and student registration. This is also the phase where the project manager ensures that the books, hands on equipment, tools and software are in place, and that the learning application or Web site is functional.

Phase 5: Evaluation

The evaluation phase consists of two parts: formative and summative. Formative evaluation is present in each stage of the ADDIE process. Summative evaluation consists of tests designed for domain specific criterion-related referenced items and providing opportunities for feedback from the users.

Bloom's Taxonomy Framework for Writing Objectives

Our training content is based on the the Revised Blooms Taxonomy Framework which is used to develop learning objectives in order to promote higher forms of thinking in education; such as analyzing and evaluating concepts, processes, procedures, and principles. The main purpose of the taxonomy is to allow educators to create learning outcomes that target not only the subject to be taught but the depth of the learning that is to occur, as well as to then create assessments that accurately report on the students' progress towards these outcomes.

Bloom's taxonomy is separated into three domains: the cognitive, the affective, and the psychomotor. Within these domains are hierarchies composed of action verbs that correspond to different levels/depths of thinking. The cognitive domain is used for the course design as it is focused on intellectual skills such as critical thinking, problem solving, and creating a knowledge base.

The learners' objectives are based on Bloom's Taxonomy cognitive domain. The training activities, assessment, the transfer of learning and learning outcomes are aligned with the objectives.

What is the difference between childcare training hours and a CEU?

A Continuing Education Unit (CEU) is a measure used in continuing education programs, particularly those required in a licensed profession to maintain their license. Childcare training hours are simply; the number of hours that a particular training or workshop was held.

CEU records are widely used to provide evidence of completion of continuing education requirements mandated by certification bodies, professional societies, or governmental licensing boards. The records also provide employers with information on training pertinent to occupations.

The Continuing Education Unit – How to Calculate CEUs

One (1) Continuing Education Unit (CEU) equals ten (10) contact hours of learner interaction with the content of the learning activity, which includes classroom, self-paced instruction, pre/post assignments, and/or homework in support of a learning outcome.

A contact hour is one clock hour of interaction between a learner and instructor, or between a learner and materials, which have been prepared to cause learning. Contact implies a connection between a learner and a learning source. For purposes of the CEU, that connection is two-way; that is, the instructor or learning source must monitor the learner's progress and/or provide some form of feedback to the learner. This definition applies for face-to face interaction as well as distance learning programs. The CEU should not be awarded for learning activities in which individuals are engaged in unplanned, unsupervised, or non-sponsored learning.

Counting Hours toward CEU

When calculating the number of CEUs for a course, the number of contact minutes must be totaled and divided by 60 to arrive at the number of contact hours. Total contact hours must then be divided by 10 to obtain the number of CEUs. CEUs must be expressed in tenths of a CEU; that is; 17 contact hours equate to 1.7 CEU; a three-contact hour program equates to .3 CEUs.

Contact hours of continuing education are calculated as follows:

1 contact/clock hour = 60 minutes of instruction = 0.1 CEU 10 contact hours = One continuing education unit (CEU) 1.0 CEU

1 contact/clock hour	=	60 minutes of instruction = 0.1 CEU
2 contact/clock hours	=	120 minutes of instruction = 0.2 CEU
3 contact/clock hours	=	180 minutes of instruction = 0.3 CEU
4 contact/clock hours	=	240 minutes of instruction = 0.4 CEU
5 contact/clock hours	=	300 minutes of instruction = 0.5 CEU
6 contact/clock hours	=	360 minutes of instruction = 0.6 CEU
7 contact/clock hours	=	420 minutes of instruction = 0.7 CEU
8 contact/clock hours	=	480 minutes of instruction = 0.8 CEU
9 contact/clock hours	=	540 minutes of instruction = 0.9 CEU
10 contact/clock hours	=	600 minutes of instruction = 1.0 CEU
